4 Powerful Ways to Think for Children to be Resilient

- by Dr Michael E. Bernard

As a parent, it is hard to know all the answers when it comes to raising children – especially in the area of building their resilience. "Bad stuff" happens to all children – and teaching your children healthy and helpful ways to think in order to manage situations makes a huge difference.

Have the following conversations with your child:

1. Healthy thinking protects you

There are two ways you can think when BAD STUFF happens to you such as when someone is being mean to you or you don't do so well at school.

Unhealthy thinking: "I'm a total loser, there's nothing good about me" which causes you to feel bad (down and worried)." Healthy thinking: "I am me and that's OK – I'm proud of who I am even when bad stuff happens" which helps you to stay confident and positive.

2. **Don't blow the badness of things out of proportion**

When someone is really mean to you, or when you don't do well at something, you could think: "This is bad, but it's not the worst thing that could ever happen to me". (There's worse things such as being eaten by a shark, being in a really bad accident, or if a volcano erupted right near where you live).

3. You don't need people to like you all the time

It's great being liked by others, but there are going to be times when you are not liked by others. A healthy and more helpful way to think is that you don't always have to be liked. The facts are that you CAN stand it when someone doesn't like you or is being mean.

4. You can choose the way to think

YOU have the power to choose the way to think when bad stuff happens or when things don't go your way. You just have to flip your thinking. Give it a try the next time things don't go your way.

Now, it takes a bit of time for children to take on board these ideas such as not taking things personally, not blowing the badness of events out of proportion and to accept that they can survive when someone is critical of them. These ideas need to be repeated and illustrated. So, be on the look-out for teachable moments where you can help your child to apply these powerful ways of thinking when faced with difficulty or challenges.

And the more often you can demonstrate by thinking aloud your own use of these ideas and the positive effects they have on you, the more quickly your children will learn them.

<u>4 ways to teach your child to think when bad stuff happens:</u>

"I am me and that's OK. I am proud of who I am."

"This is not the worst thing that could happen."

"I don't need people to like me all the time."

"I am strong. I can stand it."



The Child Safe Standards

The safety of each child at Cane is of the utmost importance. It is our duty of care to ensure each child feels safe within all environments including school, home, and the community.

To comply with the <u>Ministerial Order No. 1359 – Implementing the Child Safe Standards</u>. Cana is required to meet the Child Safe Standards 1-11. Below is an outline of each Child Safe standard. More information on each standard can be found here: The 11 Child Safe Standards

Standard 1: To establish a culturally safe environment in which the diverse and unique identities and experiences of Aboriginal children and young people are respected and valued.

Standard 2: Child safety and wellbeing are embedded in organisational leadership, governance, and culture.

Standard J: Children and young people are empowered about their rights, participate in decisions affecting them and are taken seriously.

Standard 4: Families and communities are informed and involved in promoting child safety and wellbeing.

Standard 5: Equity is upheld, and diverse needs respected in policy and practice.

Standard 5: People working with children and young people are suitable and supported to reflect child safety and wellbeing values in practice.

Standard 7: Processes for complaints and concerns are child focused.

Standard 8: Staff and volunteers are equipped with the knowledge, skills, and awareness to keep children and young people safe through ongoing education and training.

Standard 9: Physical and online environments promote safety and wellbeing while minimising the opportunity for children and young people to be harmed.

Standard 10; Implementation of the Child Safe Standards is regularly reviewed and improved.

Stanslard 11: Policies and procedures document how the school is safe for children and young people.

In future editions of the newsletter, each Child Safe Standard will be explored in further detail with examples of how it is implemented at Cana.



Message from Fr. Maurie

Greetings to everyone!

I hope you have enjoyed the early hint of Spring we had during the week, even though we know that winter will return!

That 'awareness of what is to come' is what this weekend's feast is all about. The Feast of the Transfiguration of the Lord breaks into the rhythm of Readings and Prayers for Ordinary Time that we have been having. In the Readings this weekend Jesus draws on the Prophets and the Law of the Old Testament, is affirmed by God, and is seen in something of an 'other worldly' guise. This all points to the culmination that his death and resurrection will herald in. Like the early hint of Spring during the week, this is a timely place in the calendar to have this Feast as memories of Easter slip into the past and we're still months away from the beginning of the new cycle that opens with Advent in the beginning of December.

We have another major feature in the coming week: on Tuesday (8th August), we honour the Feast Day of St Mary MacKillop, a remarkable woman whose unwavering devotion and dedication to education and the poor continue to inspire generations. Perhaps take a moment to reflect on her legacy and the profound impact she has made on countless lives with this recent video on St Mary of the Cross MacKillop <u>here.</u> There are some other reflections and prayers on an attachment with this email.

Earlier in the year I spent a few days in Penola – just over the border into South Australia – where Mary's first School was established. There is a great museum there, too on her life and mission.

Our new Ministry area, the Parish Advisory Group gathered for the first time during the week. Eleven Parishioners joined in reflection, questions, direction-setting about what this group's role will become: to advise on the life of our Parish. There are some significant points of context in which this role will develop:

- Pope Francis and 'synodality': Pope Francis told us recently that the people of the Church 'are not guests but real participants in making the Church and making up the Church'. He urges every part of the Church to call and enable the people of the Church to participate at all levels of Church life.
- Archdiocese's 'Take the Way of the Gospel': Archbishop Comensoli is grappling with the issue of
 regenerating the life of the Archdiocese when there are fewer resources available in the ways that we have
 got used to over the years. It is important for us to keep aware of this, and to see how we will fit into this
 overall project.
- Bishop's 'Visitation': Friday 6th October Sunday 8th October: our regional Bishop, Martin Ashe, will be with the Parish for three days later this year (6th, 7th, 8th October) for a 'Visitation'. This is a formal part of the Archbishop's responsibility for Parishes. Each of the four Bishops is conducting a Visitation of four Parish during this year. Bishop Ashe has a template that he has asked to be completed in preparation for this. Our Prish Advisory Group is assisting in compiling this. I will share more information about this as it comes to hand, including opportunities for you to participate in the Visitation.
- Retirement of current Parish Priest: You may recall that I indicated when I arrived in our Parish in August 2017 that my retirement comes due in September 2024. I will remind the Archbishop of this in September this year so that 'the powers that be' will have a year to plan for the transition to the next Parish Priest for our Parish. Our Parish Advisory Group will have a role in this process, too.

An exercise that the Parish Advisory Group is undertaking is 'the SWOT process': What are the Strengths, the Weaknesses, the Opportunities, the Threats when we consider our Parish's life?

I will keep you informed about all these matters through this weekly Letter and at Mass.

A well-established Ministry area in our Parish is that of sharing Holy Communion with residents in the four Aged Care/Nursing Homes in our Parish. It is a wonderful Ministry, sharing the Eucharist and also company and the life of the Parish with those residents. A number of Parishioners have retired from this Ministry over the past three year: it is important for us to recruit new members. After my mentioning this in a previous Letter, we have one new member. At Masses on the weekend of 12th-13th August, members of this Ministry will present the situation during Masses, calling for new participants.

On the world-wide scale of our Church, World Youth Day is gathering young adults in Lisbon, Portugal this week. We will hear more of the experience when some of them from our Colleges share the story on their return.

To finish off, a piece that suggests what the feast of the Transfiguration might be about; and a copy of a prayer card from the Mary MacKillop museum at Penola.

This weekend's Parish news sheet is attached, too.

There come low points in life when we are tempted to ask, "Is that all there is?" Getting up in the morning, rushing off to work or to school, doing the household chores, fighting to save enough money to pay the bills and taxes, worrying about the drip in the roof and the children's teeth, and trying not to get fat and bald and baggy-eyed? Is that all there is?

Close your eyes and look: and you'll know it's not. There are other eyes within your everyday eyes that can see into and beyond the tangle of circumstances, an inner glow, a second sight, something that not only tries to make sense of it all but that can even give life a sense of holiness!

REFLECTION

THERE'S MORE TO LIFE THAN MEETS THE EVE

This weekend the Feast of the Transfiguration breaks into our continuing series of Readings for Ordinary Time. It is the opisode where Jesus takes Peter, James and John aside. He draws the background to his coming into their awareness by presenting the great Old Testament figures, Moses (the Law) and Elijah (the Prophets). He is transformed into a visual of what they later may recall after his Resurrection from the dead. And his Baptism is recalled: "from the cloud there came a voice which said, 'This is my Son, the Beloved; he enjoys my favour. Listen to him."

This is something like 'time traveiling' where the past and the future are meshed together in the present? In our own Easter ceremonies while we bless the Easter candle we refer to Christ as 'the beginning and the end'. And along the way, he shares his life with us and takes us into his life!

Peter likes this very much- he wants to stay in this visionary state and place. However Jesus disagrees with Peter's approach (again!), and leads them back. into the ordinary, routine turn of life. Surely Peter, James and John were affected by this experience. Did it transform them in their approach to 'the ordinary'?

in our own lives there are 'transforming experiences' at times. Sometimes we don't recognise them until well after the event. It's part of our life of faith to reflect on our lives, to go below the surface. For, as the Word of God has been telling us for some weeks. not, "the Holy Spirit has made its home in us", "The Kingdom of Heaven has begun to develop even amongst you".

Part of our prayer would well be to reflect on our lives, to be open to the presence of God, to thank God for that, and to work out how to respond to and cooperate with that.

How much this was part of the 'driving force' for one of the Patron Saints of Australia– St Mary of the Cross MacKillop!

From the formal Church acknowledgement of St Mary of the Cross MacKillop:

Mary MacKillop was born in Melbourne (Australia) in 1842 and died in Sydney on 8 August 1909. She took the religious name Mary of the Cross. Responding to the isolation of colonial families, she pioneered a new form of religious life to provide education for their children. She and her sisters shared the life of the poor and the itinerant, offering special care to destitute women and children. She is remembered for her eagerness to discover God's will in all things, for her charity in the face of calumny, and for her abiding trust in God's providence.

From the Opening Prayer of her feast day Mass:

O God, source of all goodness, who have shown to us in Saint Mary MacKillop a woman of faith living by the power of the Cross, teach us, we pray, by her example to live the gospel in changing times and to respect and defend the human dignity of all in our land.

From the Solemn Blessing from her feast day Mass:

Through the example of Saint Mary of the Cross,

may we learn to recognise God's will for us and trust in God's providence;

may her life of service awaken in us a deep respect for the poor and a strong will for justice;

may we share in her courage, see with the eyes of Christian love, and learn from her holy deeds. Amen.

Re: Nationally Consistent Collection of Data on School Students with Disability (NCCD)

Every year, all schoots in Australia participate in the Nationally Consistent Collection of Data on School Students with Disability (NCCD). The NCCD process requires schools to identify information already available in the school about supports provided to students with disability. These relate to legislative requirements under the Disability Discrimination Act 1992 and the Disability Standards for Education 2005, in line with the NCCD guidelines (2019).

information provided about students to the Australian Government for the NCCD includes:

- year of schooling
- category of disability: physical, cognitive, sensory or social/emotional
- level of adjustment provided: support provided within quality differentiated leaching practice, supplementary, substantial or extensive.

This information assists schools to:

- formally recognise the supports and adjustments provided to students with disability in schools.
- consider how they can strengthen the support of students with disability in schools
- develop shared practices so that they can review their learning programs in order to improve educational outcomes for students with disability.

The NCCD provides state and federal governments with the information they need to plan more broadly for the support of students with disability.

The NCCD will have no direct impact on your child and your child will not be involved in any testing process. The achool will provide data to the Australian Government in such a way that no individual student will be able to be identified – the privacy and confidentiality of all students is ensured. All information is protected by privacy laws that regulate the collection, storage and disclosure of personal information. To find out more about these matters, please refer to the <u>Australian Government's Privacy Policy</u> (https://www.etucation.gov.au/privacy-policy).

Please be advised that amendments were made to the Australian Education Act 2013 and Australian Education Regulation 2013. Schools are required to inform parents if their child has been included in the NCCD count. As schools are mandated to provide this information to the government, parental consent is not required. If your child has been included in the NCCD count for this year, you will be notified by a member of school leadership in the coming weeks.

Nationally Consistent Collection of Data (NCCD) On School

Students with Disability

What is the Nationally Consistent Collection of Data?

Schools must now complete the Nationally Consistent Collection of Data on School Students with Disability (NCCD) every year. It counts the number of students who receive additional adjustments or "help" at school because of a disability. The NCCD helps governments plan for the needs of students with disability.

Who is counted in the data collection?

To count a student in the NCCD, schools must think through some key questions:

- Is the student getting help at school so that they can take part in education on the same basis as other students?
- Is the help given because of a disability? The word 'disability' comes from the <u>Disability</u> <u>Discrimination Act 1992</u> (DDA) and it can include many students.
- 3. Has the school talked to you or your child about the help that they provide?
- 4. Has the school kept records about the help they provide, the student needs and the reasons that the student needs this help? The school will need to keep copies of tests, student work, assessments, records of meetings, medical reports or other paperwork and information about how the student's learning is moving along over time.

Once the school decides that the student should be counted in the NCCD, they then choose a disability group and one of four levels of help that has been given to the student.

What does the word 'disability' mean in the NCCD?

In the NCCD the word 'disability' comes from the <u>Disability Discrimination Act 1992</u> (DDA). There are four types of disability that the school can choose from: sensory, cognitive, social-emotional and physical.

Many students that need help at school can be counted in the NCCD. For example, students with learning problems, e.g. specific learning disability or reading difficulty (sometimes called dyslexia), health problems (e.g. epilepsy or diabetes), physical disability (e.g. cerebral paisy), vision/hearing loss and social-emotional problems (e.g. selective mutism, Autism Spectrum Disorder, anxiety).

Letters from doctors or specialists can be very helpful for schools as they plan how to support students with their learning. Schools do not need to have these letters before they can count a

تلتي كلمة "إعقة" في NCCD من قلون النبييز بسبب الإعقة لمام 1992 <u>Disability Discrimination Act 1992 (1992 1993).</u> (DDA): هنك أربعة أواع من الإعلقة يمكن للمترسة أن تنقلر من بينها: المسية، والإدراكية، والاجتماعية – العلملية، والبنتية.

Thu Thập Dữ Kiện Nhất Định Trên Toàn Quốc Về Học Sinh Khuyết Tật ở Trường (NCCD) là gi?

Các trường hiện phải hoàn tất Thu Thập Dữ Kiện Nhất Định Trên Toàn Quốc Về Học Sinh Khuyết Tật ở Trường (NCCD) mỗi năm, để đếm/tính số học sinh cần nhận điều chỉnh hay "giúp đỡ" thêm ở trường vì bị khuyết tật. NCCD giúp chính phủ các cấp lập kế hoạch cho nhu cầu của học sinh khuyết tật.

Ai được tính trong thu thập dữ kiện?

Để tính một học sinh trong NCCD, các trường cần nghĩ qua một số câu hỏi chính:

残疾中小学生全国统一数据收集 (NCCD)

什么是全国统一数据收集?

中小学现在必须每年完成*现质中小学生全国便一看都收着。*这项活动统计因为残疾而在学校 获得额外调整或帮助的学生人数。NOCD帮助政府针对残疾学生的需求作出规划。

数据收集对象包括哪些人?

如要将学生计入NCCD、学校必须充分考虑一些关键问题;

- 1. 学生是否在学校获得那防,以便他们能在与其他学生同样的基础上参加教育?
- 这种帮助是否因为残疾而提供? "残疾"的定义来自<u>(1992年经疾费程法)</u>(DDA), 可包括很多学生。

学校确定学生应该计入NCCD后,就要选择一种残疾类别,以及四个相助等级中为学生提供的 那一个等级。

NCCD中, "残疾"是什么意思?

NCCD中, "残疾"的定义来自<u>(1982年残疾政权法)</u>(DDA)。有资种类型的残疾可供学校选择。即感官类、认知类、社会、情感类和身体类。

Safeguarding Children and Young People Code of Conduct

Acceptable behaviours

All MACS Board members, MACS Board committee members, School Advisory Council members, the Principal and all our other staff, volunteers, contractors, parent community and clergy at Cana are responsible for supporting the safety of children by:

- adhering to the school's child-safe policy and upholding the school's statement of commitment to child safety, at all times
- taking all reasonable steps to protect children from abuse
- · treating everyone in the school community with respect
- · taking into account the needs of all children and students
- listening and responding to the views and concerns of children particularly if they are telling you that they or another child has been abused or that they are worried about their safety/the safety of another child
- promoting the cultural safety, participation and empowerment of Aboriginal and Torres Strait Islander children (for example, by never questioning an Aboriginal or Torres Strait Islander child's self-identification)
- promoting the cultural safety, participation and empowerment of children with culturally and linguistically diverse backgrounds (for example, by having a zero-tolerance for discrimination)
- promoting the safety, participation and empowerment of children with a disability (for example, during personal care activities)
- · ensuring as far as practicable that adults are not alone with a child
- reporting any allegations of child abuse to the school's leadership (or child safety officer if the school has appointed someone to this role)
- understanding and complying with all reporting obligations as they relate to mandatory reporting and reporting under the *Crimes Act 1958* (Vic.)
- understanding and complying with all obligations as they relate to the reportable conduct scheme including reporting allegations of reportable conduct in accordance with the school's reportable conduct policy
- reporting any child safety concerns to the school's leadership (or child safety officer if the school has appointed someone to this role)
- \cdot ~ ensuring as quickly as possible that the child is safe if an allegation of child abuse is made
- reporting to the Victorian Institute of Teaching (VIT) any charges, committals for trial or convictions in relation to a sexual offence by a registered teacher, or specific allegations or concerns about a registered teacher

ensuring they comply with any and all applicable professional or occupational codes of conduct.

Unacceptable behaviours

All MACS Board members, MACS Board committee members, School Advisory Council members, the Principal and all our other staff, volunteers, contractors and clergy at Cana must not:

- ignore or disregard any suspected or disclosed child abuse. This includes but not limited to physical / mental abuse, neglect and any form of maltreatment by an adult which is threatening to a child.
- develop any special relationships with children that could be seen as favouritism (for example, the offering of gifts or special treatment for specific children)
- exhibit behaviours with children which may be construed as unnecessarily physical (for example, inappropriate sitting on laps)
- put children at risk of abuse (for example, by locking doors)
- initiate unnecessary physical contact with children or do things of a personal nature that a child can do for themselves (for example, toileting or changing clothes)
- engage in open discussions of a mature or adult nature in the presence of children (for example, personal social activities)
- · use inappropriate language in the presence of children
- · express personal views on cultures, race or sexuality in the presence of children
- discriminate against any child, including because of age, gender, race, culture, vulnerability, sexuality, ethnicity or disability
- · work with children while under the influence of alcohol or illegal drugs
- have contact with a child or their family outside school without the school leadership's or child safety officer's (if the school has appointed someone to this role) knowledge and/or consent or the school governing authority's approval (for example, unauthorised after-hours tutoring, private instrumental/other lessons or sport coaching); accidental contact, such as seeing people in the street, is appropriate
- have any online contact with a child (including by social media, email, instant messaging) or their family unless necessary (for example, providing families with eNewsletters or assisting students with their schoolwork)
- · use any personal communication channels/devices such as a personal email account
- · exchange personal contact details such as phone numbers, social networking sites or email addresses
- \cdot photograph or video a child without the consent of the parents, guardians or carers
- · consume alcohol or drugs at school or at school events in the presence of children.
